

LVENTURE GROUP JOINS CLUB ACCELERATORI: 1 MILLION EUROS FOR 6 STARTUPS IN THE PORTFOLIO

LVenture Group enters Club Acceleratori with 200 thousand Euros and Club Acceleratori invests 1 million Euros in the startups which came out the last Acceleration Program of LUISS ENLABS, completing the round of over 2.25 million Euros

Rome, December 23rd, 2015

LVenture Group, holding company listed on the Italian Stock Exchange, becomes part of **Club Acceleratori**, the third Club Deal conceived by **SiamoSoci**, the Italian marketplace that connects investors and non-listed assets. Club Acceleratori, launched in September 2015, is a project that sees the main Italian accelerators co-investing in the most promising Italian startups with a network of business angels related to SiamoSoci.

The peculiarity of the project Club Acceleratori is linked to the multiplier effect on investment addressed at startups. Accelerators, in fact, have the opportunity to draw, in favour of their startups, an amount equivalent to five times the investment supplied to the Club, thanks to the entry of Business Angel lured by the possibility of investing in a diversified high-quality portfolio.

Along with Nana Bianca and I3P, LVenture Group participates in the Club with the double role of operator of Venture Capital and owner of the Startups Accelerator LUISS ENLABS "The Startups Factory", managed in partnership with LUISS University.

As mentioned in the [press release published on October 22nd, 2015](#), the formalization of this agreement with SiamoSoci fulfils the commitment of 1 million Euros on the six startups which came out the last Acceleration Program of LUISS ENLABS and were presented during the Investor Day in June 2015. Depending on the mechanism explained above, by providing 200 thousand Euros to Club Acceleratori, LVenture Group acquires the possibility to draw financial resources for 1 million Euros, completing a round of investment of the total value of over 2.25 million Euros.

*"We are very pleased with this agreement that closes a round of over 2 million Euros for our startups! Thanks to Club Acceleratori we will manage to speed up the fundraising even more, expand the network of third-party investors and at the same time indirectly hold shares in the capital of startups supported by other accelerators in the Club - said the **CEO of LVenture Group Luigi Capello** - The agreement also allows us to consolidate further the relationship with SiamoSoci with which we have already started a strategic [partnership](#) in May 2015 and defined various fundraising operations".*

Dario Gudici, CEO of SiamoSoci said in turn *"We are happy that LVenture Group, a protagonist of the Italian startups ecosystem, has got on board of this project that brings together for the first time institutional investors, private individuals, innovative companies and accelerators. We believe that the alignment of these actors around mutual interests is the winning formula for the growth of innovation. LVenture Group, building on work carried out in recent years, represents an important value added to the Club "*

Following this agreement, the total amount of 2.25 million euros of investments in favour of 6 startups in LVenture Group's portfolio will be divided as follows:

- [Brave Potions](#) will receive 150 thousand Euros from Club Acceleratori, which are part of a round of the total value of approximately **205 thousand Euros**, of which 55 thousand Euros have been previously supplied;
- [Majeeko](#) (Sync Ltd.) will receive 150 thousand Euros from Club Acceleratori, which are part of a round of the total value of **415 thousand Euros**, of which over 265 thousand Euros have been previously supplied;
- [Moovenda](#) will receive 150 thousand Euros from Club Acceleratori, which are part of a round of the total value of about **535 thousand Euros**, of which 385 Euros have been previously supplied;
- [Nextwin](#) will receive 150 thousand Euros from Club Acceleratori, which are part of a round of the total value of over **300 thousand Euros**, of which over 150 thousand Euros have been previously supplied;
- [Verticomics](#) will receive 250 thousand Euros from Club Acceleratori, which are part of a round of the total value of over **395 thousand Euros**, of which over 145 thousand Euros have been previously supplied;
- [Voverc](#) will receive 150 thousand Euros from Club Acceleratori, which are part of a round of the total value of **410 thousand Euros**, of which 260 thousand have been previously supplied.
